

PUBLIC NOTICE OF REGULAR SCHOOL ELECTION FOR EAST CENTRAL COMMUNITY SCHOOL DISTRICT

PUBLIC NOTICE IS HEREBY GIVEN to the qualified electors of the East Central Community School District, in the County of Jackson, State of Iowa, that the regular school election has been called and ordered held in and for said school district on September 8, 2009, where at there will be submitted to said electors, three candidates for two Director-at-large positions, for a four (4) year term, as indicated on the facsimile ballot accompanying this official notice.

FURTHER PUBLIC NOTICE IS HEREBY GIVEN to the qualified voters of the Eastern Iowa Community College District (Merged Area IX) in the County of Jackson, that the school election has been called and ordered held in and for said College District on September 8, 2009, where at there will be submitted to said electors, one public measure question for Proposition "D", as indicated on the facsimile ballot accompanying this official notice.

THE POLL FOR SAID COMMUNITY SCHOOL shall open at twelve (12) o'clock noon and shall close at 8:00 o'clock p.m. All voters shall vote a paper ballot. An AccuVote Optical Scan, precinct count voting machine shall be used at said election to cast ballots. An AutoMARK Voter Assisted Terminal, a ballot marking device, shall be available to assist disable voters.

THE FOLLOWING POLLING PLACE shall be used for said election. Said polling place is accessible to disabled voters and does comply with ADA regulations.

ALL QUALIFIED RESIDENTS OF IOWA, VAN BUREN AND WASHINGTON TOWNSHIPS AND THE CITY OF MILES IN JACKSON COUNTY AND QUALIFIED RESIDENTS OF DEEP CREEK TOWNSHIP IN CLINTON COUNTY WHO ARE PART OF THE EAST CENTRAL SCHOOL DISTRICT SHALL USE THE FOLLOWING POLLING PLACE:

ALL QUALIFIED RESIDENTS OF UNION TOWNSHIP AND THE CITY OF SABULA IN JACKSON COUNTY AND QUALIFIED RESIDENTS OF ELK RIVER TOWNSHIP IN CLINTON COUNTY WHO ARE PART OF THE EAST CENTRAL SCHOOL DISTRICT SHALL USE THE FOLLOWING POLLING PLACE:

ABSENTEE VOTERS shall vote in the Auditor's Office in the Courthouse at Maquoketa during regular working hours from 8:30 a.m. to 4:30 p.m. weekdays. As an alternative method, upon submission of a State of Iowa's Official Absentee Request Form, with a written signature, an absentee ballot will be sent by U.S. Mail to the qualified voter. Deadline to request an absentee ballot to be mailed is September 4, 2009.

ELECTION DAY REGISTRATION at the polling place for the precinct you currently live in will require proof of residence with a current address in the precinct and identity with a photo ID and if you register after August 28, 2009 pre-registration deadline. You may vote in the auditor's office after the voter pre-registration deadline and you will follow the election day registration procedure. You will fill out a voter registration form, show your proof of residence and identity, sign an oath and be given an absentee ballot to vote. The best form of ID is a valid Iowa driver's license with current address. Contact the Auditor's Office if more information is needed regarding Election Day Registration.

ALL QUALIFIED ELECTORS of said school residing in said district are hereby notified to appear on the date and during the aforesaid hours of said election.
